## UXBRIDGE ROVERS ANGLING & CONSERVATION SOCIETY

### DO'S AND DON'TS

**DO** read the following rules very carefully before you start to fish the Society waters.

**DO** check the venue closure dates before going to a venue to make sure it is available, and then check the maps and rules for the venue.

**DO** remember that **NIGHT FISHING** is **NOT** allowed (except where otherwise stated in the individual fishery rules).

**DO** display your Car Permit in the windscreen of your car and park only in the designated areas.

**DO REMOVE ALL LITTER** from your swim before leaving and take it home for disposal.

**DO NOT** on any pretext fish beyond the boundaries of the fisheries.

### CONSTITUTION

1. The Society shall be known as UXBRIDGE ROVERS ANGLING & CONSERVATION SOCIETY, it's objects shall be the protection of the sport of angling, and to foster good fellowship and friendly competition among its members.

2. All members shall hold a current Environment Agency Licence. The Society waters will be closed for all forms of fishing for the period 15th March to 15th June inclusive (except where otherwise stated in the individual fishery rules). Any member unable to produce their rod licence, id card and membership card whilst fishing will be asked to leave the fishery.

## MEMBERSHIP

3. All members shall be full members, either Senior or Junior. A Junior shall become Senior if his/her 18th birthday falls before the date of the subscription renewal, i.e. 1st June. Intermediate membership shall be open to individuals between the age of 18 and 21, on production of their full time student union card.
4. No person shall be admitted a member of the Society unless they have fully completed an application form in a satisfactory manner. Those wishing to join before June 16th may do so at one of the three membership meetings held during the period 15th March to 15th June. After the last of these meetings only postal applications will be accepted. Each such application must be proposed and countersigned by an existing member.
5. Any member accused of a breach of the rules of the Society shall be called before the committee to make answer to the charge. The committee shall report their findings and recommendations to the next open meeting, and the members shall decide on any disciplinary action to be taken
6. A member having complaint against another member and desiring such complaint to be brought before the Society shall attempt to ascertain the other members membership number and shall send full details to the Secretary. Due notice should be given to all parties concerned of the date, time and place of the hearing of the complaint.
7. The complaint shall be heard by the management or disciplinary committee whichever body may be appointed to hear the complaint. After hearing the complaint the committee shall give its



decision on the matter. The hearing committee shall report its decision to the next open Society meeting where the party or parties concerned shall have the right of appeal against the decision. The members present at the open club meeting shall have the right to accept the hearing committees decision, to decide the manner on appeal or to refer the matter back to the hearing committee for further deliberation as pursuant to rule 26. The membership's decision shall be final and binding on all parties.

8. The committee shall have the right to summon a member to attend before the committee for any breach of these rules or bringing discredit upon the Society. The member shall be deemed summoned before the committee upon the secretary sending due notice by recorded post to the last known address of the member. Should the member fail to attend at the time and place stated upon the said notice without an acceptable reason for non-attendance, the member shall be liable to suspension or expulsion pursuant to these rules.

9. A member completing 20 years continuous membership and attaining the age of 65 shall be entitled to be nominated as an Honorary Life Member of the Society, by the vote of members at any monthly meeting.

## MEETINGS AND STANDING ORDERS

10. Club meetings will be held on the 3rd Wednesday of February and July.
11. The Chairman or Vice-Chairman shall commence the meeting at 8.00 p.m., (should either be

unable to attend a Committee member will officiate), and advise members of the agenda.

12. The Secretary will read the minutes of the previous committee meeting to members present. The Secretary will record the minutes throughout the meeting.

13. Correspondence, when relevant, will be read.

14. Up to date Match reports will be given by the Match Secretary.

15. Items members wish the committee to discuss and assess will be recorded by the Secretary (for evaluation at the next committee meeting and report back to the Society at the earliest opportunity).

16. Once items 12-15 have been dealt with, the meeting may then continue as an open discussion appertaining to angling (with either guest speaker, films or any other method members require).

17. Members shall respect the authority of the Chairman when addressing the meeting. The Chairman may order temporary suspension from the meeting of any member who fails to respect the authority of the Chairman.

18. The Annual General Meeting shall be held on the 3rd Wednesday in February at the Society Headquarters. An alternative venue may be decided by the management committee, in which case the membership will be advised in the newsletter to be published between 31st November and 31st January. If that is not possible the Secretary shall arrange for due notice to be published in the angling press on two separate occasions prior to the meeting.

19. The order of business shall be as follows:-

A. Proposals for alteration to the rules, which shall have been presented to the Secretary in writing no later than the first Wednesday in the November prior to the meeting. No amendments other than provided for in Rule 29. Such proposal shall not be carried unless it receives the vote of a majority of the members in attendance. A proposition when seconded shall be open to discussion and no member shall speak more than once in a debate, except to raise a point of order, or seek information, on which the Chairman shall rule. The proposer shall have the right to reply to the debate immediately before the vote is taken.

B. Minutes of previous A.G.M.

C. Financial report and balance sheet for the year ended December 31st, Auditors report and recommendations.

D. Annual subscriptions, entry fee and Memorial Fund Levy for the coming season.

E. Correspondence.

F. Election of officers; President, Vice President, Chairman\*, Vice Chairman\*, Hon.-Secretary\*, Membership Secretary\*, Assistant Secretary (NFA)\*, Assistant Secretary (Memorial Fund)\*, Assistant Secretary (Venues)\*, Assistant Secretary (Entertainment)\*, Hon.-Treasurer\*, Society Captain\*, Newsletter Editor\*, Disabled Rep\*, Junior Rep\*, Fisheries Chairman\*, Trustees (2) Auditors (2) and Fisheries Managers (7). \* Management Committee 14 members in total.

20. Fisheries committee will consist of 6 members, including the chairman. They will hold separate meetings and report to the committee meetings. They will manage their own accounts.

21. The management committee may co-opt additional members to the fisheries committee should the need arise.

22. The additional members to sub-committee 20 & 21 will be put forward for acceptance by the representatives elected at the A.G.M.

23. In the event of an officer or committee member resigning or otherwise ceasing to hold office, the vacancy shall be filled at the discretion of the Management Committee.

24. An extraordinary Annual General Meeting may be convened at the behest of the Management Committee or where such a request is made (within a four week period) to the Secretary by no less than 10% of the membership. The Secretary to give notice of the date and venue for such meeting in the same manner as provided in rule 18.

### **MANAGEMENT COMMITTEE**

25. The Management Committee shall comprise of 14 members who will be elected at the A.G.M. The committee shall meet on the 1st Wednesday in each month if there are matters requiring their attention and any two from Chairman, Vice Chairman, Treasurer and Secretary plus 3 other committee members will form a quorum, with names present recorded. In an emergency, the Secretary in consultation with the Chairman or Vice-Chairman to arrange a meeting giving committee members not less than 3 days



notice. The Management Committee will be totally responsible for the management and running of this Society during its year of office.

26. To consider any disciplinary matter under rule 5.

27. To consider any matter not provided for under these rules, or any question of their interpretation.

28. To decide a limit of numbers to be admitted to the Society from time to time. They may nevertheless recommend the admission of a member even if this exceeds the limit agreed.

29. To consider the proposal for change of rules as put forward under rule 19A and have the right to recommend an amendment, also to move a change of rule subject to the provisions of rule 19. In both these cases the committee shall appoint one of their number to act as spokesman.

30. To co-opt the Trustees if required on matters of financial importance and for members of sub-committees if necessary.

31. To consider the proposed venues for the next season.

32. Detailed minutes on committee meetings shall be read at next open meeting, minutes to be accepted.

33. The committee shall consider any item put forward by a member and reply at the next open meeting. A member may write to the Secretary with any matter that the member wishes the committee to consider. The Secretary will bring the matter to the attention of the committee and advise the member in writing of the committee's response and any subsequent action it intends to take.

## SUBSCRIPTION AND FEES

34. The full annual subscription and any other dues shall become payable with the application form. Notice of such items and the amounts, shall be sent to members by the Membership Secretary, and shall be paid to him at his address by cheques or postal orders



35. No member (Except Hon. Life Members) shall be entitled to a membership card etc. until his Subscription is paid. Members not having renewed their Subscription by 1st June shall be liable to forfeit their right to renew membership, and new members will be admitted within the limits laid down by the committee. Annual membership shall be valid for the period 1st June to 31st May.



36. Newly accepted members shall pay the entry fee as decided in rule 19D and the full annual subscription and levies etc. However the committee shall have the discretion to introduce special offers (reductions) on the subscriptions to promote membership of the Society.

## MATCHES AND PRIZES



37. Matches shall be arranged as nearly as possible to the second Sunday in each month. Members shall receive a fixture card notifying these dates and any other events.

38. The management committee will nominate two of their number and a representative of the membership to put forward proposals for the next seasons match venues. Based on those proposals the management committee will determine the match venues for the next season. The Venue Secretary will be solely responsible for booking the venues.

39. No Society championship venue can be changed after that venue has been selected and printed on the official venue list unless a change is made under rule 51.

40. Cancellation of coach seats shall be made to the Match Secretary not later than the Monday prior to the match date. Members booking a coach seat shall be liable for full fare. Members attending a club championship match using transport other than the official club transport shall be liable for full fare. (Special dispensation can be granted by the committee in special cases.)

41. All members must book with the Match Secretary to attend the match.

42. Coach fares shall be set by the committee.

43. Club matches will be fished to the following rules:-

i. Matches are fished on a pegged down basis, competitors will fish from drawn pegs.

ii. Matches are fished all in, except for Zander, Pike and Trout.

iii. The match will start and end with a blast on a whistle.

iv. Parent and Junior, or husband and wife will draw first. Junior or wife will fish to or from the next higher peg to that drawn. Pensioners will draw at the Captains discretion.

v. Keepnets may be put in the water, and the depth plumbed before the start of the match.

- vi. No baiting of the swim is allowed before the start of the match.
  - vii. No raking of the swim is allowed before the start of the match.
  - viii. One rod only in use, others may be made up, but not baited.
  - ix. If wading, it must be possible to touch the bank with either hand when in a standing position. This rule may be amended at the Captain's discretion if the venue makes it impractical.
  - x. No bloodworm or jokers are to be used.
  - xi. No competitor will be weighed in if there is any litter in or around the swim.
  - xii. Weighing in must be witnessed by a third party.
  - xiii. Any disputes or infringements, must be reported to the Match Captain at the earliest possible time, but before departure from the venue.
  - xiv. Floating baits are not allowed on still water venues.
44. Society Captain will be responsible for the running of the matches once the Society members have arrived at the bank side. He will be responsible for the selection of pegs on a permanently pegged fishery and also for pegging on all other fisheries. He will be able to delegate assistance in pegging on any match.



He will listen and take note of any complaint from one member against another and report back to the committee. The committee shall then act as in Rule 7.

45. The scales shall be carried and weighing in conducted at Society Captain's discretion.



46. The end of pools time for each match will be decided by the committee and matches will start one hour later except when exceptional circumstances apply. Matches shall be fished for seven hours except during the period November to February when they shall be fished for six hours. A fish hooked before the cease fishing time, and still being played after the whistle, shall be eligible to be weighed in. If it is considered necessary to change the cease fishing time, or reduce the length of the match, the Match Captain and at least two committee members shall decide. Members will be advised of the change prior to match start.

47. Points to be awarded on each match, 50 for top Weight, 49 for second etc. If more than 50 members weigh in then points will start at 1 for the lowest weight and scale upwards. In the event of equal weights the aggregate points for the members tying shall be divided between them. The aggregate of points over the season shall decide the points Cup Winner and Runner-up etc.

48. All pools are optional and will pay out as follows:-  
Overall pools:- 50%, 30%, and 20% to 1st, 2nd, and 3rd. Specimen pools:- 100% to the outright winner.

Section pools:- Divided equally between the section winners. Paid out to 1st and 2nd in each section. Winners of the overall pool will not be eligible for prizes from the section pool.

49. A prize of £10 will be given to a member who in a Society championship match breaks any existing Society record for the following species:- Roach, Dace, Chub, Bream, Tench, Carp, Rudd, Barbel and Perch.

### **KNOCK OUT CUP COMPETITION.**

50. An entrance fee shall be payable by any persons wishing to take part in this competition. Preliminary rounds are to be fished in August and September where any competing member must qualify by weighing in. The competition commences on the October Society match and is to be fished on a knockout basis. The pairing of participants in this competition, is to be conducted by the Match Secretary prior to the start and witnessed by a third party. The highest weight to decide the winner in each pair. If opponents fail to turn up the other must weigh in. Failure to weigh in - either or both parties are eliminated. In event of equal weight, a toss of a coin to decide winners except in final unless agreed by finalists. All entrance fees to be paid to winner.

51. On all Society match dates where it is ascertained to the satisfaction of the Society committee that the original venue is un-fishable, a new venue will be chosen after normal Society pick-ups have been completed. The new venue to be decided by a vote of members present.

52. In the event of a coach failing to turn up for a match, a decision to be made at Denham roundabout regarding transport consolidation

53. Non-members will be allowed to fish Society matches provided there are vacancies at the closing

date. Normal match fees will be charged, except at the Society's own waters, in which case the normal Guest Ticket price will apply.

### **IMPORTANT.**

Members must notify the Match Secretary or Secretary not later than the Monday before, if they wish to attend the match.

### **SOCIETY PRIVATE WATERS**

54. No fish of any species shall be introduced to the Society waters without the consent of the committee, landlord and the Environment Agency. Game fish may be removed in season. No live bait will be used on the Society waters. No coarse fish may be removed from the Society waters without the consent of the Landlord and the Environment Agency.

55. Night fishing is not allowed on the Society waters, with the exception of rule 66 or where otherwise stated in the individual fishery rules. No member is allowed onto the Society's waters until one hour before sunrise and must leave no later than one hour after sunset.

56. No discarded line or line of any sort shall be left on any part of the fisheries. No member may carry firearms, air gun or portable radio on to any fishery.

57. No member may take a dog on to any of the Society waters, except where they are on the fishery for the sole purpose of baiting the water and then only if this does not contravene the licence for that fishery. This rule does not apply to areas where the general public have a right of access or to members with guide dogs.

58. Members shall endeavour to prevent fishing or trespassing by non-members or other unauthorised persons, or any damage to Society property. Instructions of authorised bailiffs must be respected, and the regulations as printed on the Society membership card are to be observed by all members.
59. Junior members under the age of twelve (12) must be accompanied by an adult when fishing any of the Society waters.
60. Juniors must obtain written permission from Parents or Guardian before joining the Society.
61. All vehicles being driven onto Society waters must display, in a prominent position, the members vehicle identity permit. Any vehicle found on Society waters not displaying the members identity permit must be reported to the committee, and may render the member(s) liable for disciplinary procedures.
62. Members and guests vehicle must only be parked in the prescribed parking areas. Any vehicle found to be parked in an out of bounds area may render the owner liable for immediate expulsion from the Society.
63. Senior members shall be permitted to take one guest on to private Society waters. Guests may not fish unless/until accompanied by a senior member. The member must obtain a day ticket from the Secretary, or from the tackle shops listed on the club card. If the guest ticket cannot be produced, then the guest and the member will be asked to leave the water. The price of guest tickets shall be fixed at each A.G.M.
64. Fly fishing is not permitted on Society waters at any time.



65. The individual fishery rules define how many rods may be used on each fishery.

66. On one Saturday night during the period 15th June to 15th March an all night match called the club Gala Match may take place on one of the Society's waters. This item to be considered annually by vote at subsequent AGMs. Special rules will apply and will be announced/displayed at the draw.

67. The following restrictions apply to all Society waters: -

- i. Only barbless hooks may be used
  - ii. Barbel will not be retained in keepnets except in a bona-fide match when they shall be weighed and returned immediately.
  - iii. The use of 'boilies' is banned except where otherwise stated in the individual fishery rules.
  - iv. Members shall fish from designated pegs only.
68. The Management Committee can at its discretion introduce (and if appropriate, cancel) a prize draw, which would consist of a number of small monthly prizes drawn at club meetings. With an annual grand prize, drawn at the Dinner and Dance.

### **THE MEMORIAL FUND.**

The Fund originated in 1965 as a tribute to the Society's former Chairman for many years. It has since been extended to commemorate the respect of members for other officers who have given outstanding services to the Society over a period of years.

The three Trustees are appointed at the A.G.M. of the Society and jointly administer the fund, one of them acting as Secretary/Treasurer. Monies of the fund are kept in a separate bank account, and withdrawal of any monies requires the signature of two Trustees.



Income of the fund is maintained by a levy on each member (excepting Honorary Life Members), and may be supplemented in any manner approved by members at a monthly meeting. Voluntary donations are welcome.



An account of the income and expenditure and balance in hand or bank will be presented at the AGM.

The Trustees shall have the authority to make immediate grants in cash or kind at their own discretion except in the case of a member of less than one year's duration, which case shall require approval at a monthly meeting. Further grants in case of hardship or extended illness and the question of members or widows of members to whom Christmas grants or gifts are sent, shall be decided at monthly meeting.

### NOTES

Any change in the foregoing constitution of the fund may be dealt with at the AGM.



## FISHERIES GUIDE

For rules governing these fisheries, please refer to these pages and the Society rules.

Some Society venues are closed for club competitions at certain times. Before visiting any of the Society waters, check the club fixture list to ensure that the venue is open for pleasure angling.

No parking in the Mission grounds.

## RIVER COLNE - DENNHAM A40

Uxbridge Rovers have extended their arrangement with Boyer Leisure to include access to the section of the River Colne from the A40 down to the old Uxbridge Road - see map overleaf. This stretch is reported to hold barbel into double figures and night fishing will be allowed.

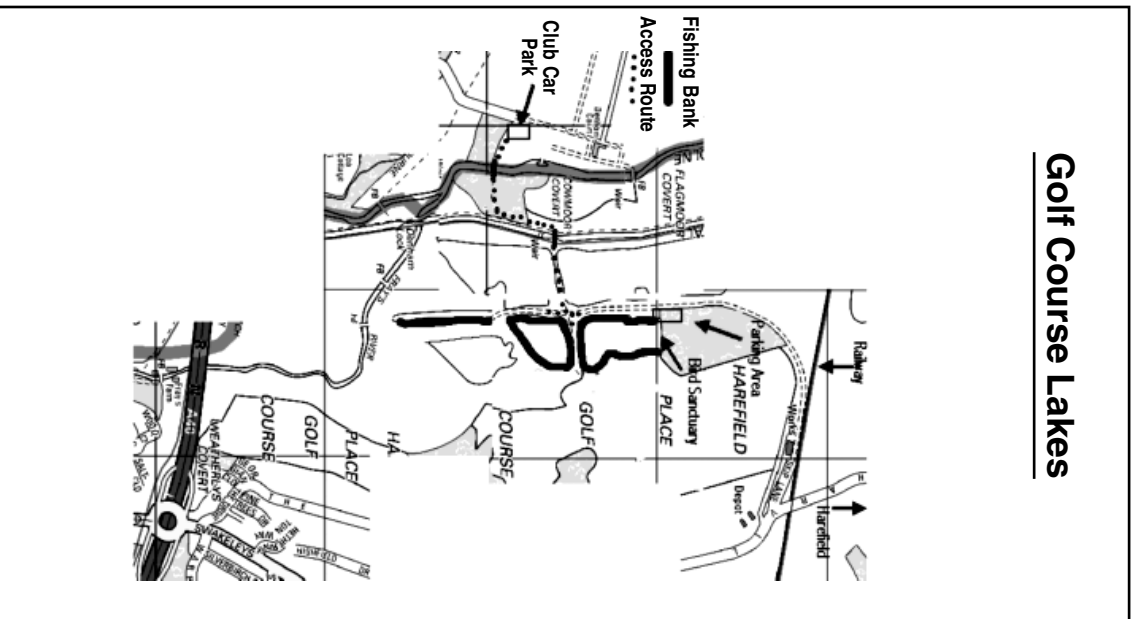
There is a small car park adjacent to The Tiger Cubs Indian Restaurant on the A4120 Oxford Road. The car park lock number is on the membership card.

### IMPORTANT NOTICE

The bankside and the car park area of the River Colne at the Anoopam Mission (above A40M) is out of bounds due to reasons beyond the control of Boyer Leisure Limited or Uxbridge Rovers ACS. **PARKING AND FISHING IS STRICTLY PROHIBITED ON ANY AREA OF THIS BANKSIDE.** This includes the section inside the pedestrian gate at the side of the Anoopam Mission.

 It is not permitted to drive beyond the Society car park to drop or collect the fishing gear.

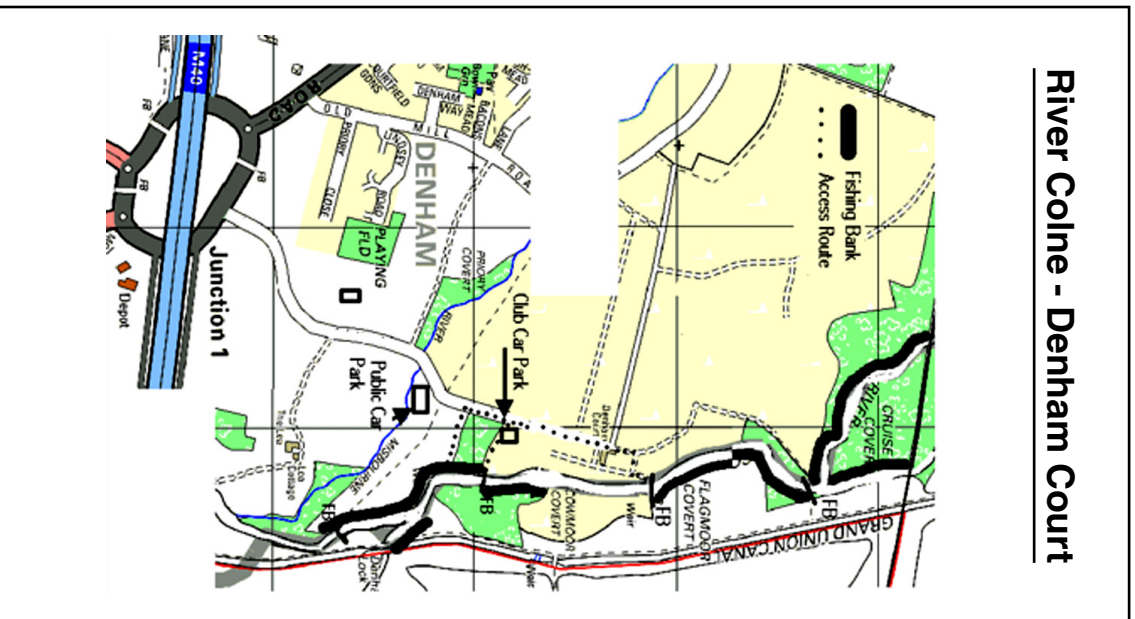

## River Colne - Denham Court



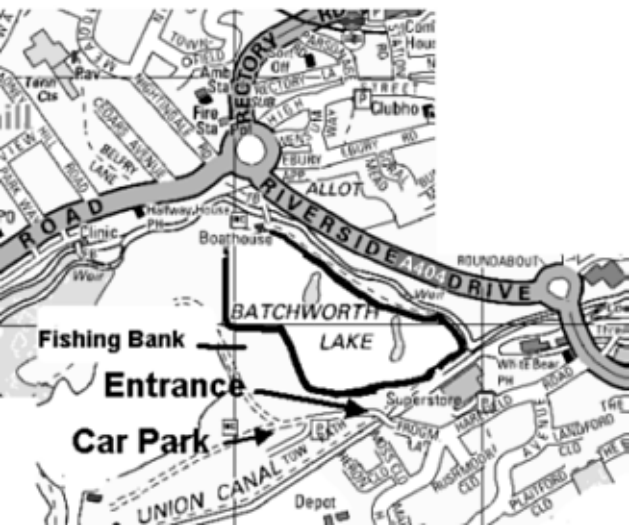
## **BATCHWORTH LAKE – RICKMANSWORTH AQUADROME**

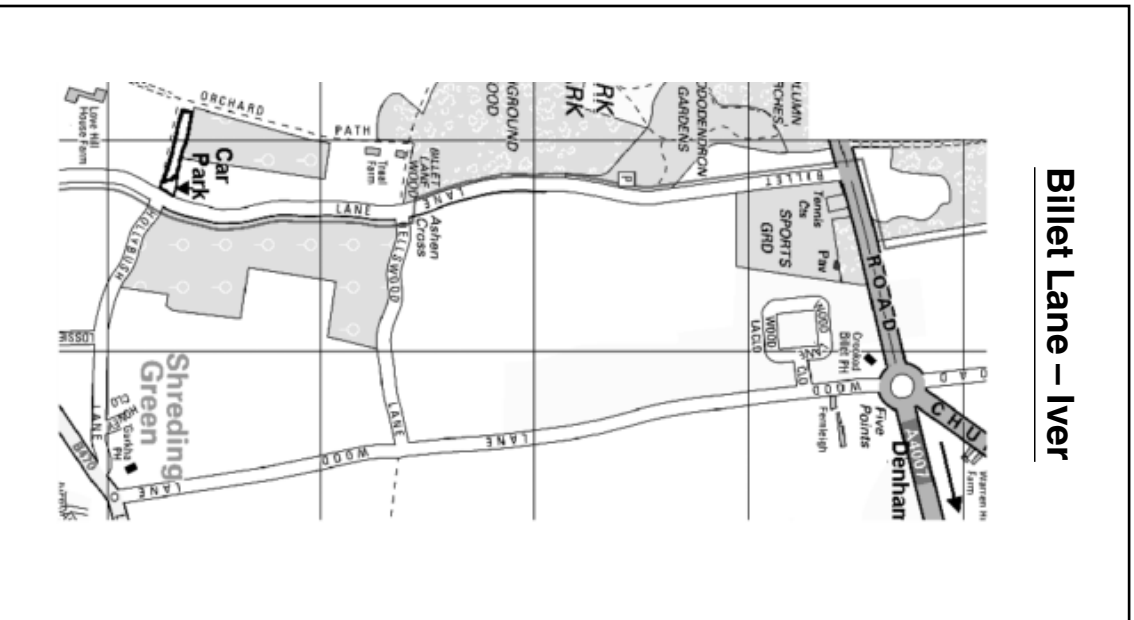
